CLIMATE & HEALTH EQUITY – A CLINICAL PERSPECTIVE ON BUILDING RESILIENCE

KEYNOTE ADDRESS

As an accomplished surgeon and leading voice in global health, Dr. Shaneeta Johnson brings a powerful perspective to NC BREATHE 2025. Dr. Johnson will use her expertise to unpack the direct clinical implications of environmental shifts on patient health, strategies for healthcare providers to adapt, and the imperative for health systems to champion community health.



Shaneeta Johnson, MD, MBA, FACS

Associate Dean and VP of Global Health Partnerships & Engagement Professor of Global Health, School of Global Health Chair and Professor of Surgery, Department of Surgery Meharry Medical College Fellowship Director, Climate and Health Equity Fellowship Medical Society Consortium on Climate and Health

Dr. Shaneeta Johnson is a distinguished surgeon, educator, and researcher at Meharry Medical College, where she is the Chair and Professor of Surgery. She is also Associate Dean and Vice President of Global Health Partnerships and Engagement at Meharry School of Global Health. Dr. Johnson is a member of the planning committee of the National Academy of Medicine Action Collaborative on Decarbonizing the US Health Sector and the American Hospital Association Community and Environment Technical Expert Panel, as well as a Fellow with the National Medical Association.

A recognized expert in global health, robotic minimally invasive surgery, and bariatric surgery, Dr. Johnson has dedicated much of her work to health equity, surgical sustainability, and environmental justice. She has served on advisory panels for the FDA, Joint Commission, and legislative committees. Her expertise has afforded her invitations to speak nationally and internationally.

Among Dr. Johnson's many accolades are the 2021 inaugural SAGES Social Justice and Health Equity Award, the 2020 National Medical Association Emerging Leader Award, the 2020 Top Women in Medicine honoree, and the 2018 Atlanta 40 Under 40 award. She has also received various awards for her excellence in teaching and has been named the 2022 Georgia Trend Top Doctor.

UNDERSTANDING ENVIRONMENTAL DETERMINANTS OF RESPIRATORY HEALTH

Drawing from over two decades of experience as an environmental health scientist, Dr. Sacoby Wilson will discuss the various health burdens faced by communities associated with environmental factors. He will break down the critical role of public health in addressing these challenges and the solutions we should be focusing on now.

Dr. Sacoby Wilson is a Professor with the Department of Global, Environmental, and Occupational Health and the Department of Epidemiology and Biostatistics at the University of Maryland, where he directs The Health, Environmental, and Economic Justice Lab. He has over 20 years of experience as an environmental health scientist in the areas of exposure science, environmental justice, environmental health disparities, air pollution studies, community resiliency, and many others.

Through partnerships with community-based organizations, he studies and addresses environmental justice and health issues, translating research into action. Dr. Wilson founded 17 for Peace and Justice, co-founded the DC/Maryland/Virginia Environmental Justice Coalition, and co-founded the Mid-Atlantic Justice Coalition.

His impactful research and advocacy have earned him numerous accolades, including the 2008 Steve Wing International Environmental Justice Award and the 2015 APHA Environment Section Damu Smith Environmental Justice Award. He has also been honored with the 2011 Reverend Dr. Martin Luther King Jr. Social Justice Award and the 2018 Taking Nature Black Environmental Champion Award, among others, for his dedication to creating a healthier and more equitable environment.


This session will address the psychological impacts of environmental disasters and chronic pollution on communities, and strategies for healthcare providers and community leaders to foster mental well-being and resilience.

Virginia Guidry, PhD, MPH

NC Department of Health and Human Services (NC DHHS)

Dr. Guidry leads the DHHS Occupational and Environmental Epidemiology Branch. She has worked on environmental health and justice issues in North Carolina since 2003, including experience in community-based research, communications, and applied epidemiology.

Arlinda Ellison, DHSc, MS, HHC

Alamance County Health Department

Dr. Ellison is a public and holistic health educator, coach, researcher, and facilitator. She is also an adjunct faculty member at Legacy Holistic Health Institute. She has over 20 years of experience in public health education and community-engaged research.

KEYNOTE ADDRESS

As a pioneer of environmental justice in the U.S., Charles Lee has invaluable insights into where policy changes must be made. He will draw from his experiences in the EJ movement and his work for the EPA to discuss the evolution of environmental policy, effective strategies for meaningful community input in environmental regulations, and the role of federal agencies in supporting state and local initiatives for healthier communities.



Charles Lee Visiting Scholar Howard University School of Law

Charles Lee is a widely recognized thought leader and founder of the EJ movement in the U.S. He wrote the landmark 1987 report, *Toxic Wastes and Race in the United States*, organized the historic 1991 First National People of Color Environmental Leadership Summit, and helped spearhead the emergence of federal EJ policy – including the establishment of the EPA Office of Environmental Justice, National Environmental Justice Advisory Council, and Presidential Executive Order 12898 on environmental justice.

Throughout his career, Lee created the United Church of Christ's EJ program, directed EPA's Office of Environmental Justice, and served as the Senior Policy Advisor for Environmental Justice at the EPA's national program office on EJ and external civil rights. He has led efforts for collaborative problem-solving, transformed brownfields redevelopment into a community revitalization paradigm, incorporated EJ into EPA's rulemaking process, advanced EJ at the state level, and continued efforts to address cumulative impacts. Currently, Lee is a Visiting Scholar at the Howard University School of Law.

Lee has written numerous reports and articles and has received many awards. His work has been featured at the Smithsonian Institution and other museums, along with the archival of his professional papers at the Library of Congress.

Drawing on her extensive background in pharmacology and environmental toxicology, as well as her work in community engagement and research at North Carolina Central University, Dr. Hoffler will draw connections to the scientific realities of air pollution to its direct impacts on student health and learning.

Dr. Undi Hoffler is an expert in pharmacology and environmental toxicology, with over 19 years of research experience focusing on metabolism and biomarkers of exposure. She conducted her research at the National Institutes of Health/National Institute of Environmental Health Sciences and the U.S. Food and Drug Administration/National Center for Toxicological Research. Currently, Dr. Hoffler serves as the director for the Office of Research Compliance and Technology Transfer (ORCTT) at North Carolina Central University (NCCU), where she also contributes as a health equity researcher.

Dr. Hoffler's expertise extends to supporting the creation of University-IP-based startups and mentoring students in social entrepreneurial ventures. She has served as principal investigator on multiple Technology Enhancement Grants funded by the North Carolina Biotechnology Center, facilitating studies that enhance the licensing potential of innovative technologies. Additionally, her office plays a crucial role in protecting faculty, staff, and students who report research noncompliance.
